You can designate a fixed percentage of your estate, a fixed amount, or a residual amount after all your heirs have been provided for. We also wanted to let everyone know our big news. We now offer annuities through a subsidiary of the Dechomai Foundation that manages over \$1.4 billion in unrestricted assets backing charitable gift annuity payments.

A charitable gift annuity is where you, the donor, contribute property in exchange for a guaranteed lifetime income. (Dechomai follows the American


Council on Gift Annuities suggested rates which typically average from 4 to 8 percent.)

In a letter to her new school community, St. Raphael principal Ann W. Cwirko quotes encouraging words from the prophet Jeremiah to welcome back students and staff:

“For I know the plans I have for you,” declares the Lord, “plans to give you hope and a future.” [Jeremiah 29:11]

The newest principal of the Hamilton Catholic grade school, dubbing herself “first and foremost, no matter how old I am, a child of God,” aims to fulfill her mission to foster a spirit of family and love of God during her term of leadership.

Cwirko attended St. Charles Borromeo School, Cinnaminson, and Holy Cross High School, Delran, before graduating with a bachelor's degree in education of the handicapped from Trenton State College (now The College of New Jersey), Ewing. She began her teaching career in an elementary multiple handicapped class in Lumberton, then taught at the high school level in Delran for five years.

After taking a hiatus to raise her daughter,

Cwirko returned to the classroom as a fourth grade teacher in Our Lady of Perpetual Help School, Maple Shade, for two years. The educator then transitioned from fourth grade to the junior high level, teaching sixth through eighth grade students while acting as co-coordinator of the language arts program and co-moderator of the school's student council.

“It was during my twelfth year at Our Lady of Perpetual Help School that I was invited to consider educational leadership,” Cwirko recalled in her biographical profile. “After much prayer and personal reflection, and the support and encouragement of my family and colleagues, I stepped out in faith, left my beloved school, and began the next chapter of my journey, with the teacher now becoming the student.”

Cwirko returned to school to earn a master's degree in school administration from Rowan University, Glassboro. While completing the graduate program, she returned to two of her alma mater schools, this time as teacher; Cwirko taught second grade in St. Charles Borromeo School, and served as graduate intern in Holy Cross High School.

Cwirko expressed her admiration for the fellow faith-based teachers who have gone before her, stating, “I stand on the shoulders of giants. I have also been blessed with the amazing opportunity to journey with so many amazing children, their parents, and the parish community fostering a spirit of family and love of God. I am confident these experiences will continue at St. Raphael School.”

The principal's “plans to give hope and a future” can be found within her mission statement to the St. Raphael community:

“The mission of a true educator and educational leader is to recognize and celebrate the unique, God-given gifts and talents that each learner possesses, teacher and student alike; to guide

them on their journey, empowering them to become active participants in their learning by fostering a spirit of inquiry and discovery, collaboration, and reflective practice; to encourage each individual to rise to meet the challenges of our ever-changing world, and to instill

a sense of wonder and desire to become life-long learners who plan for a future where they can achieve their full potential and make a positive contribution to our world.”

Here is the Email message I received

from Ann on Jan. 3, 2024:

Good evening Kathleen.

I have received your communication from my parent's estate attorney, Thomas D. Begley, III, LLC. My father, Edward P. Rhodes was an EXCEPTIONALLY PROUD graduate of Villanova University ... Class of 1960. As parents of five ... Catholic education was INCREDIBLY important to my father and mother. They worked tirelessly to provide us with everything we needed ... and most of what we wanted ... the priority being a faith based, Catholic education. As their oldest child, I can speak to the true depth and breath of their desire to instill in us the importance of our faith as well as having a Catholic education. As a Catholic school educator and later a Catholic school principal, I celebrated each and every day the GIFT of my faith and the ability to witness my love of God and love of learning with my students, teachers and community. After my baby sister, **Andrea Leanor Rhodes**, passed away from cancer when she was 17 years old, my parents ... along with my brother and two sisters ... wanted her legacy to live on beyond her 17 years. To celebrate her life and honor her memory, the family's heart's desire was/is to provide opportunities for students who may not have the financial means to attend Villanova University to do so.

To establish the **Andrea Leanor Rhodes Memorial Scholarship of the Blue and White Scholarship Foundation** would honor her legacy. Q: How do you create a legacy?

A. For families that wish to create a true legacy and keep future generations involved with the perpetual award of scholarships, we offer Naming Rights with legacy benefits. Your heirs remain involved with the applications for scholarships funded by your endowment. The amount of these annual scholarships is calculated based on the earnings attributable to your endowment gift.

Q: How much money does it take ? A: There are two key types of gifts

Scholarship in Perpetuity - \$25,000+ will establish a named scholarship in your name or your beloved's name. This scholarship can be targeted for a particular major or school such as the Engineering School or a particular major such as Biology. The student will be chosen based on your guidelines

Family Legacy Fund - -\$150,000+ gift will also establish a named scholarship with the above benefits plus full participation in the selection of the student by you and multiple generations of your family, who may participate in selecting each Scholarship, including reviewing Scholarship applications. Each succeeding generation in your family will be reminded of your generosity.

In addition you will be permanently remembered by each scholar by the presentation of your bio to he or she upon receipt of their scholarship.

Q: Do I need to fund my gift in one payment?

A: No. We can accept pledges for up to five years, or you can create a gift through a planned gift (will, trust, life insurance policy). You can even invite friends and family to donate to your fund.

This placed a significant burden on us as we had to reevaluate our finances and ultimately we decided to downsize and move houses. In the midst of these challenges, our new home in Florida was devastated by Hurricane Ian, causing extensive damage and rendering it uninhabitable. The repair costs amounted to \$116,000, which depleted our savings and left us burdened with loans. The Blue and White Scholarship has been a lifeline for us, alleviating some of the financial stress and allowing me to continue my education at Villanova.

Interning at Morgan Stanley

I'd like to talk about my experience so far interning at Morgan Stanley in their Manhattan office for their Fund Services division. From a high-level view, Morgan Stanley Fund Services is a global hedge fund administrator



providing best-in-class service and product solutions. The division is relatively new and is rapidly growing, with offices in New York, London, Hong Kong, Glasgow, Mumbai, and Bangalore.

The internship is a ten-week program, including two weeks of training and four, two-week rotations (below is a pic from our orientation day at the Intrepid Museum). The rotations are in the Middle Office and Investor Services, the Anti-Money Laundering (AML) rotation, and the program on the Product Development (ProdDev) team. If I had to pick a favorite, I think the Middle Office rotation suits my strengths as a finance major the best. Within Middle Office, there are two functions: Trade Affirmation and Treasury Services. Trade Affirmation deals more with making sure the hedge funds' trades execute properly and facilitating the relationship between the hedge funds and their prime brokers. Treasury deals more with cash management, wire, and swaps margin services. Though Middle Office has been my favorite so far, I enjoyed the ProdDev rotation as well, as I was able to demonstrate my creative capabilities.

Being from Long Island, I've watched

my dad commute to work with the LIRR every morning for as long as I can remember. Now that I'm doing the same, it's been both exciting and surreal at the same time. Over the past few years, I feel like I've come a long way from working as a Door Dash driver and power washing houses to now working at one of the most respected, successful financial firms in the world. 

Entrepreneurship has evolved significantly over the last couple of decades, and the future is still opportunistic for the individuals who dare to take the risk. Combining Passions of Mine-Sports & Technology

Growing up, two constants in my life were always sports and technology. In elementary school, my favorite part of the day was when the school laptop cart rolled into the classroom, and I got the chance to browse the web and play around with all the cool settings that a computer has. Eventually this passion for just utilizing a computer transformed into a passion for coding once high school hit. Outside of school while growing up, everything for me revolved around sports. You could name a sport, and at one time in my childhood I probably played it. From the baseball diamond to the football field to the ice hockey rink, I was always playing any sport I could once the school day ended.

Fast forward to college, and the Villanova Fall Involvement Fair my freshman year. As a freshman, the involvement fair is the best opportunity to find clubs and student organizations that can be vital in making your college experience a great one. It was at this involvement fair that I discovered a new club at Villanova: The Villanova Sports Analytics Club. It was a brand-new club just started and was ran by a now good friend of mine who was the president at the time. My sports analytics journey began just like that. Going into my last year at Villanova now, I am the President of the Villanova Sports Analytics Club. I just kept getting more involved each year going from member to junior chair to President. The club has allowed me to leverage my technical skills to analyze sports and see games in a different lens. I am honestly not sure if I ever would have got as involved in the sports



analytics space if it were not for joining the club here at Villanova.

Given my interest in analyzing sports as I have talked at length about and Villanova Basketball's tough season last year, I think it's a perfect time to do a brief analysis to see how the Wildcats should be doing this season. Villanova lost 3 key players from last year's squad who were all starters in Caleb Daniels, Brandon Slater, and Freshman phenom Cam Whitmore. Daniels averaged 14.2 pts per game, Slater averaged 9.7 pts per game, and Whitmore averaged 12.5 pts per game. That totals to 36.4 pts per game that Villanova will have to make up for some way to have their offense be just as good as last year. Villanova brought in 4 transfers for this upcoming season. Looking at their point scoring averages on their teams from last season, TJ Bamba averaged 15.8 pts per game, Hakim Hart averaged 11.4 pts per game, Tyler Burton averaged 19.0 pts per game, and Lance Ware averaged 2.0 pts per game. That totals to 48.2 pts per game that Villanova should have gained in point scoring this year, while they only lost 36.4 pts per game. Thus, Villanova should be having a much better season than in Head Coach Kyle Neptune's first year at the helm. However, this has certainly not been the case. The Villanova Men's Basketball Team is currently on the Bubble to make the NCAA Tournament after another brutal loss to Xavier on Wednesday February 1st. The Wildcats lost 56-53 and

now sit at 12-11 on the year and are 5-7 in Big East Conference play. Villanova's NCAA tournament hopes are currently on life support as according to ESPN, Villanova will be left out of March Madness given their current tournament resume. So, what's wrong with the Wildcats? Well, going back to my initial and simple analysis using points per game, the Wildcats are not getting the offense they expected out of the players they picked up in the transfer portal. TJ Bamba is averaging 10.5 pts per game, Tyler Burton is averaging 8.5 pts per game, Hakim Hart is averaging 7.3 pts per game, and Lance Ware is averaging 1.5 pts per game. All of which are significantly less



than the pts per game they had on their previous teams last year. This means Villanova lost 36.4 pts per game in players that left the program last year, and only replaced it with 27.8 pts per game in scoring in reality this year. Not the 48.2 they were expecting from all of these transfer additions. Thus, being able to score on the offensive end has once again proved to be a struggle this year. If the Wildcats are going to shock the college basketball world and get back to the big dance after missing the NCAA tournament last year, their key transfer portal additions are going to have to step it up.

Tax Tips for Students

American opportunity tax credit....

lets you claim all of the first \$2,000 you spent on tuition, books, equipment and school fees — but not living expenses or transportation — plus 25% of the next \$2,000, for a total of \$2,500.

Lifetime learning credit...

lets you claim 20% of the first \$10,000 you paid toward tuition and fees, for a maximum of \$2,000. Like the American opportunity tax credit, the lifetime learning credit doesn't count living expenses or transportation as eligible expenses. You can claim books or supplies needed for coursework.

Student loan interest deduction

borrowers write off up to \$2,500 from their taxable income if they paid interest on their student loans.

Saver's credit

runs 10% to 50% of up to \$2,000 (\$4,000 if filing jointly) in contributions to an IRA, 401(k), 403(b) or certain other retirement plans. The percentage depends on your filing status and income.
