## **Executive Director's Message**

I was recently asked, Why is the Blue White Scholarship Foundation needed when there is a \$600 million campaign underway and how are we different? I thought it was such a good question that it is now the focus of our web-site's Home Page. By the way, please everyone "Like" our Facebook Page. It helps us with the statistics we need to get Grant Funding which we are going to try for the first time... So......

#### Why We Are Needed

After Villanova University has provided all of the financial aid it can, there are still many students who experience a gap in funding in their junior and senior years, putting them at risk of not being able to graduate. According to U.S. News & World Report 50% of undergrads determined to have financial need and the average aid package is \$33,845. Villanova reports a 20 % shortfall in what they can provide in financial aid. This makes the average shortfall to be about \$13,000. The Blue White Scholarship Foundation (B.W.S.F. also known as the Blue White Club) was started by Alumni that give not only to the University, but dig deeper into their pockets to help students directly, specifically these Middle Class students who don't qualify for enough financial aid from the school or those students who have encountered an unexpected financial hardship resulting in a "Short Fall" or "Tuition Gap."

#### Who We Help

B.W.S.F. helps those students from Middle Class families and students who have encountered an unexpected financial hardship such as a parent who has been laid off from work or is underemployed, or a parent or sibling who has become ill and the medical bills have created an extreme burden, or they come from a large family and the money has simply run out. In all cases the students are "Working their way" through school and in some cases are responsible for 100% of their tuition. In all cases the result is a "short fall" or "tuition gap" in funds available.

## A Life Time of Service to Our Country, Our School and Our Community

#### The Colorful Dr. Ronald "Bud" Russo

There are people that have dedicated their lives to others and it is our fortune that Dr. Ronald F. Russo came to Villanova. Dr. Russo "Bud" was one of the four founders of the Wildcat Club, the predecessor to the Blue White Scholarship Foundation. He did it because he wanted to give back to the school and the students. So who is Dr. Bud Russo?

Growing up in the Bronx, Bud says he was a passing student. He wanted to apply to Villanova but everyone said "The school was so good" and they wouldn't let him apply. Instead, at 17 years old, Bud volunteered for the United States Marine Corps. He was sent to China to serve with the 1<sup>st</sup> Provisional Marine Division, 5<sup>th</sup> Marine Regiment, ABC Company as a Browning automatic rifleman. When he came back. "I went down and looked at Villanova – 1946 – and I got goose bumps walking through the campus. Green grass! I came up the Paoli Local. I didn't really deserve to be accepted, but with the GI Bill ... Hey, I'm very loyal to the Marines." Thanks to "Uncle Sam" Bud would be able to afford college, however he'd be on his own to pay for his .M.D.

Bud married Mary Margaret Moore in his senior year at Villanova and immediately started a family. During his years at Villanova and the first 2 years at Temple, he worked at every possible job to support his young family while going to school. From driving a taxi, working at the ACME and A&P, caddying, mowing lawns, and working at a pharmacy, gas station, lumber yard, waiting tables and even painting houses, he did it all. Mary also worked both at home and outside jobs to help raise their eight children.

After graduating in 1952 from Villanova, Bud went to Temple Medical School. Upon graduation from Temple, Dr. Russo joined the Bryn Mawr Hospital staff after serving as an intern there. He then opened a practice in Ardmore and practiced for 30 years. Starting in 1967, Bud started to watch the football practices at Villanova and help out with any medical issues. Dr. Russo was in attendance at every football sporting event he could make. Then he attended the basketball games and all the other sporting events. His days and nights were jam-packed. He would watch the practices and check any injuries. His days were already busy with patients and family obligations but soon the university needed his presence to tend to all the team sports 8 months a year. Bud devoted his expertise to the student athletes, from 4pm-6pm every afternoon at the Jake Nevin Building. As the need grew, a physical therapist and orthopedic surgeon were added. In 1986 the NCAA rules changed requiring a paid Athletic Physician and Bud was asked to continue on as the Team Doctor for The Villanova Athletic Program. He was instrumental in establishing the sports medicine program that now exists for Villanova Athletes. What started with Dr. Bud Russo, a volunteer physician for 15 years, (1970-1985) and a paid physician for 5 years (1985-1990) has grown into a state of the art Sports Medicine Program.

In 1991 his "love of country" called him back to service and he volunteered for Desert storm at the young age of 59 years old. For the second time Bud volunteered to fight in a war. This time he went not as a Marine, but as a Navy Physician. Not only was Bud raising 8 children with Mary, and running his own practice and working at Villanova, but he also joined the U.S. Navy Reserve Medical Corps in 1982 to support the U.S. Marine Air Wing at Willow Grove. Eight years later in 1991 he volunteered to support Operation Desert Storm and served on active duty for 6 years. Bud a Private First Class in the U.S. Marines retired from the Navy in the Rank of Captain in September, 1997. He then went to work at Neumann Medical Center Emergency Department, in Philadelphia. When Neumann closed, Bud worked in the E.R. at Northeastern Hospital. He had an amazing personal and military career, all the while he was the Villanova University athletic teams physician from 1970-1990. Don't you think for a minute he isn't still a practicing physician! He now works one day a week for the Community Volunteers of Medicine and is taking care of the indigent. He will tell you "You miss out on life if you don't volunteer"

In terms of service to the university, Russo has been most everywhere, serving as the Alumni Association president in 1970. His articles, for the alumni association's publications, were written with a certain tart frankness. During the 70's he sat on various advisory panels. Bud has served as the Chairman of, The Alumni Annual Giving Committee, The Planning Committee and Athletic Committee of the Villanova Senate, The Alumni Class Agent; The President of the VU General Alumni Association, President of The Villanova Educational Foundation (the "Wildcat Club" predecessor of BWSF), and now he currently serves on the Board of the Blue White Scholarship Foundation aka, The Blue White Club. His honors include the Alumni Medal, the coveted Loyalty Award, the Joseph Molinari award and the Varsity Club Hall of Fame award. Bud tells me now "Everything I dreamed and everything I have worked for has come true in the past 15 years for the University. We are on top academically and our sports program is outstanding. Our charismatic President, Father Peter Donoghue has now taken the school to a National University status and the Cats are ranked # 1. Now, I continue to help by raising money for students in need by supporting the Blue White Scholarship Foundation."

Bud Russo may have mellowed a bit over the years and may not be as much of a lightning rod as he once was. But, through the years, there is one unshakable truth that survives. Bud Russo is still a colorful character ... and his favorite colors are still Villanova Blue and White. A guy who is as Villanova as the twin spires, or Bartley Hall.

## February "Donor of the Month" Pam Beatty Laudadio

Yesterday morning I met Pam Laudadio for a cup of coffee. I wanted to meet this dynamic woman who was so enthusiastic about helping our Blue White Scholars. I had called her after our accountant told me I had to find out the face value of an insurance policy gifted to BBSW by Pam. All assets must be accounted and this policy had been around a long time. I wondered why Pam a Varsity Softball athlete who was a starting rotation Short Stop (1978-19800, had given us an insurance policy, so I asked her. Here is her reply:

"When I was new to financial planning and attending a motivational meeting, a speaker representing Special Olympics spoke to us about their organization. At 26 years old, I was familiar with Special Olympics, but to see the impact it made to the athletes was heartwarming to say the least. The speaker encouraged us to think about using life insurance to leverage donations not only to Special Olympics but to other non-profit organizations that are near and dear to us.

I decided to purchase two policies; one for Special Olympics and one for the VU Wildcat Club, now Blue White Scholarship Foundation. I continue to donate premium payments to each policy and someday, hopefully very far into the future, the Blue White Scholarship Fund, as well as the Special Olympics will be the recipients of a larger donation through the life insurance proceeds."

I stayed to ask Pam about the Types of Life Insurance Charitable Gifts. She told me there are three basic choices in making a charitable Gift of life insurance.

- One: The donor may give an existing policy to charity in which all incidents of ownership should be assigned to the charity and the charity named as the policy's beneficiary.
- Two: The donor may apply to a new policy on his or her life with the charity as the original policy owner and beneficiary (subject to state insurable interest laws) and
- Three: The donor may designate a charity as the beneficiary of a policy that the donor continues to own.

I than asked her what some of the advantages and disadvantages for each type. Here is the answer:

#### Gifts of Existing Life Insurance Policies

A donor may give an existing life insurance policy to charity and be eligible for an income tax charitable deduction, provided the donor assigns all rights to the charity (i.e., naming the charity as policy owner and beneficiary). A donor who retains any right in the policy after assignment will jeopardize the charitable deduction for the gift.

#### Gifts of New Life Insurance Policies

To make a gift of a new life insurance policy, a donor should transfer funds to the charity. The charity then should be the applicant, owner and beneficiary of the new policy issued on the life of the donor. The donor then receives two tax benefits:

- The initial premium amount donated may be deductible.
- The death proceeds of the policy will not be included in the donor's gross estate at death (because the donor never held any incidents of ownership). State insurable interest laws should be checked to assure this is permissible. The great majority of states have enacted legislation to make it clear that a charitable organization has an insurable interest in a donor. States do not consider a charitable organization to have an insurable interest in a donor. The question of insurable interest generally arises only at the time of policy issue, not when some subsequent assignment occurs.

### Designating a Charity as the Life Insurance Policy Beneficiary

If a donor does not desire to make an immediate gift with respect to an existing policy, the donor may retain ownership and control of the policy but name a charity as beneficiary. This will not produce an income tax charitable deduction at the time the beneficiary designation is made, but it will result in an estate tax charitable deduction for the death proceeds includible in the donor's gross estate and passing to the charity at the insured donor's death

Would you like to create your own Legacy? You can by Charitable Giving Through Life Insurance- Pam can walk you though the basics. She has not only made BWSF a beneficiary of a Life Insurance Policy but she has become an expert on the subject! Read what Pam has to say

"Most people could not write a check today for \$100,000 to their chosen charity. But through life insurance, it can cost you very little to be very generous. Life insurance enables you to make a substantial future gift by making small premium payments over time.. **Great idea for our scholars to give back!** 

The advantages of using life insurance as the instrument to fund a charitable giving plan include:

- You may qualify for income, gift and estate tax deductions.
- · The gift is given without disrupting other assets reserved for your family.
- Death benefits are paid promptly to the charity.
- · Gifts of life insurance do not increase estate liquidity needs.
- · The policy's growing cash value also may be borrowed by the charitable institution for special needs.

The federal government has structured income, gift and estate tax laws to encourage you to share your assets with charitable organizations.

The tax benefits you may receive include lower:

- · Income tax liability
- · Gift tax liability
- Estate tax liability

Options for funding charitable donations through <u>existing life insurance</u>. Great idea for older donors! There are two common options to consider when making charitable donations through an existing life insurance policy or new one. Choose the one that best meets your needs.

- **Option 1** Name a charitable beneficiary to receive all or a portion of the proceeds of a policy you already own or purchase a new policy, naming a favorite charity as beneficiary. In either case, you own the policy and you pay premiums. You cannot deduct the premium payments, but you maintain control of the policy (should you decide to change the beneficiary at some point).
- **Option 2** Donate an existing policy\* to a favorite charity, or make cash donations to the charity for the purpose of purchasing life insurance. This provides you with a current income tax deduction, while the charity pays the premiums and maintains ownership of the policy.

## Act of Kindness—February's Person of the Month

Ken Gerg, Class of 1958, Discovers The Holy Grail

The Fountain of Youth has been discovered! It'd true! Just take one look at Ken Gerg. That's Ken Gerg docking after another day at the office. This photo was taken at the end of the Cameron County Canoe & Kayak Classic. Gerg, who captained this event for nearly two decades, still says the local course is his favorite. I'm not sure if he is jesting. Canoe News describes it like this-"About three fourths of a mile into the event the canoes encounter the confluence of Portage Creek and the Driftwood Branch. A whirlpool here sent numerous folks in for an early season swim. Three miles further along the survivors encountered "German Rock" rapids and many howling spectators hoping to witness and photograph their friends making the event a "biathlon" (to include swimming). Another two miles presented the paddlers with "Devils Elbow" with its fast unpredictable water and ROCKS just below



the surface. About a half mile from the finish, "Sterling Run Rapids" always added an exciting end to those who may have thought that the fun was over. Despite the different challenges which the water/ice altered stream presented, the race is still always a roaring success. The best races occurred when there was a heavy winter snow blanket with a late thaw and good snow melt, runoff. The race has taken place in a blinding snow storm, in a drought, at flood stage and on one occasion, had to be "started" about three miles above Driftwood as it was the

first "open water". The river from there back to Emporium was frozen solid. In fact, ice axes and picks were used the day before the event to open up a channel through which the canoes could pass, but the event went on!"

When I spoke with Ken he told me, "My claim to fame at Villanova is my Freshman roommate was Jim Moran (55), Captain of the world record track team. My sophomore roommate was Ron Delany (58) the Irish Gold Medal winner in Melbourne, Australia in 1956 and usher in my wedding. My junior and senior roommate was Joe Ryan (59), Captain of the Basketball ........

.....Since graduation in 1958 two of my daughters have followed me-Sharon Eggstein, who graduated in 1982, and Carolyn in 1987. Carolyn subsequently married "Number 32" of the 1985 NCAA Championship Basketball team-Harold Jensen...I started a manufacturing company in 1965 and retired in 1987," so states the very modest Gerg.

In actuality, Gerg has been a major force in Cameron County as an industrial entrepreneur. He and other visionaries began Pennsylvania Pressed Metals, a pioneer in the powdered metal industry. Its arrival was a godsend in Emporium after the fading of Sylvania left the county in near-economic ruin. Not only did Gerg's handiwork boost the economy and bolster the local labor force, he also involved himself in many community organizations, but his favorite are canoe organizations.



For the Gerg's, April through November is spent preparing for, and traveling to, as many as 15 races per season. Ken's wife JoAnne is the head of his "pit crew" and that's no joke. "She's a 'bank runner' and there's just no way you can make these long races without bank runners," Ken explained. "They are responsible for getting you your Gatorade, aspirin, Aleve, candy bars for a sugar boost and whatever other concoctions you need to get through the race." Bank running is no easy job because access points to the race course are sometimes difficult to find and when you do get to them, you never know if your paddler has already gone by. For the uninitiated, some of the races are long, REAL long -- close to 100 miles. That realization puts the bank runners' jobs in perspective. In 2008, Ken now 72 years old, was awarded the extremely prestigious United State Canoe Association Paddler of the Year Award. He has paddled and raced over 20,000 miles paddled over a career that spans 30 years. He told me that when he gets old he plans on taking up golf! I thank Ken for being the first to give money to the Endowment by using the Newsletter Giving Envelope's. Keep on paddling!




